Hollywood is known for its glitz and glamour, with its big budget motion pictures and the lifestyles of the rich and famous, but like anything shining and bright, there's always a darker, more mysterious side. Murders and suicides, the Black Dahlia most notably, have splashed across the headlines from time to time and piqued the interest of the general public. Celebrity ghosts are said to haunt certain Hollywood locales, some visiting multiple locations. Queue the eerie music and a clap of thunder. That flash of lightning illuminates a sign welcoming us to Tinseltown. Come explore the darker side of Hollywood with us.



The day begins with a trip to the Sowden House. Evoking a sense of mystery and exoticism, the iconic house was designed by Frank Lloyd Wright, Jr and has hosted everything from photo shoots to films and television shows. It is said that the house may even hold the key to the notoriously unsolved Black Dahlia murder. You'll then visit the Hollywood Roosevelt Hotel. Home and hangout to numerous celebrities in their heyday, among them Clark Gable and Marilyn Monroe, the 12-story building on the Hollywood Walk of Fame has seen numerous ghost sightings and mysterious activity. As the day continues, you'll make a visit to the historic El Capitan Theater, where a suicide took place in the balcony and a manager met an untimely end in his office. Next on the tour, you'll pass the Knickerbocker Hotel, where the ghost of Rudolph Valentino is said to have haunted the bar, among other locations. From there, a trip to the Hollywood Forever Cemetery, where such luminaries as Judy Garland, Mickey Rooney, Douglas Fairbanks and Toto are laid to rest and others are said to lurk the grounds. The town is full of paranormal sightings, and there's no way of knowing how true they are until you see for yourself. A stop will also be made midday for a devilishly delicious lunch at HMS Bounty, which also claims to have it's share of ghost stories!



Dine at this L.A. restaurant that is known to be built atop a place that was popular in the 20s to dump murdered bodies. Visitors to the Bounty's ladies' room be warned - you may feel the pinch of a leering phantom that is said to live there.

These terms and conditions (the "Agreement") describe what you are legally entitled to expect from us when you book your trip through us, in addition to important obligations you make as a customer that affect your legal rights. The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" "customer" refers to the customer visiting our website, and/or booking a reservation through us.

### YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirety. Pertaining to private group tours, the lead participant assumes the responsibility of sharing these Terms and Conditions with each trip participant, including payment of all amounts when due. M.S. Tours, Inc. is not responsible for any participant's unawareness of the Terms and Conditions due to the failure of the lead participant to share this information with all other participants/customers. You acknowledge and agree that we may change these terms and conditions from time to time and that those changes become effective immediately. You agree to be bound by the terms and conditions that are in effect at the time of your travel or cancellation, whichever applies. You agree that it is your responsibility to be familiar with these terms and conditions and to check back from time to time for any changes.

You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use, (b) you are legally authorized to act on behalf of those you represent and accept these terms and conditions on their behalf, and (c) the information supplied by you or members of your group is true and correct. Should any prices for such components be increased, M.S. Tours, Inc. reserves the right and the customer acknowledges the right of M.S. Tours, Inc. to increase the tour and travel arrangement price in the amount of any such increase in price. Any customer given notice of increased cost shall have the right to terminate the reservation and obtain a full refund of all amounts paid to M.S. Tours, Inc. unless such payment was expressly made on a non-refundable basis. ### PARKING

### NON-OPERATION OF A TOUR

Most tours are based on a minimum number of participants. M.S. Tours, Inc. makes every effort to ensure that tours meet their minimum requirements. However, if the tour drops below the minimum number of participants, cancellation or modification of the tour may occur at the sole discretion of M.S. Tours, Inc. We may offer alternative tour dates or other travel arrangements. You may choose to accept these arrangements or to cancel your booking, in which case a full refund will be provided. Any air cancellation will be in accordance with the terms of the carrier and M.S. Tours, Inc. will not be liable for the carrier's refusal to make any refund whatsoever. In such case M.S. Tours, Inc. will not be liable for any additional costs incurred outside of the tour prices such as visa and passport fees, travel insurance or any other purchases made by the guest in anticipation of the tour.

### CHANGES TO ITINERARIES

The customer acknowledges that tour itineraries, accommodations, travel arrangements and other aspects of a tour must at times be modified or cancelled due to acts of God, (including but not limited to, fires, earthquakes, floods, acts or threats of terrorism) unavailability of accommodations or other causes beyond the reasonable control of M.S. In such cases, we will arrange for the substitution of comparable services. As an example, significant changes do not include the following, change of accommodation to another of the same standard, any change in the itinerary due to holiday, facility closure or weather, and any minor itinerary change where we make a reasonable substitution. M.S. ### FORCE MAJEURE

M.S. Tours, Inc. cannot accept liability, provide any refund, or pay any compensation where the performance or prompt performance of our contractual obligations is prevented or affected, or you otherwise suffer any loss, injury, death, inconvenience or damage as a result of circumstances amounting to "force majeure." "Force majeure" means any event or circumstances which we or the supplier of the services in question could not foresee or avoid.
